Supervised Visitation & Parent Aide Programs Supervised visits and parent aide services are among the most important services that a family receives when they become involved with the Department of Child Safety. The goal of this program is to support and empower parents as they work to fulfill their DCS case plan requirements in order to reunify with their children. Under contract with the state, Aviva supervised 3,500 court-mandated visits for families in dependency. We served 80 families and 200 children.

Form 990, Part III, Line 4b:

Community Resources Program For 40 years, Avivas Community Resources Program has been an important resource for DCS staff to obtain everyday necessity items for foster children and vulnerable families in our community. The goal of this program is to provide dignity, hope, joy to these families. Our staff and volunteers work tirelessly to ensure that we make available basic necessity items. This past fiscal year, our program reached 4,900 children and 1,100 families in Pima County. We provided over \$46,000 in food cards, shoe and school uniform vouchers and to supplement in-kind donations of basic necessity items. In addition, we distributed 10,000 new and gently used clothing items, 17,000 pairs of socks, underwear, and diapers, 9,000 school supplies items and backpacks, and 930 hygiene and cleaning kits. Over 400 volunteers gave their time and talents to provide children with 2,380 beautiful handmade quilts valued at \$59,500 and 4,800 bags for kids duffel bags valued at \$42,750. This program is supported entirely by community donations and grants. The Community Resources Program also oversees other programs including an internship program designed to offer college students experience in the field of social service. During the past fiscal year, we screen and placed 30 interns at various DCS offices. Our Life Book staff created over 15 beautiful books that tell a child's story in a sensitive, accurate and age appropriate way. These books are done for children that will not be reunified with their parent and will be adopted. In addition, one of the agency's largest events is our Christmas on Tuesday Holiday Giveaway. Monetary contributions and in-kind donation of toys helped us serve over 2,000 foster children during Christmas 2017.

Form 990, Part III, Line 4c:

Parent Support Program This program highlights the important role that parent peers play in helping families reunify and in preventing the recurrence of child abuse and neglect. Launched in 2011, it started as a postreunification support program for parents who at some point had their children removed from their care and subsequently been reunified. The goal is to reduce the rate of recidivism amongst reunified families. It has now expanded to assist families with an out-of-home dependency and those receiving in-home services as part of a prevention strategy. Parents can attend a weekly support group or get individual mentoring. The program is run entirely by trained staff and volunteers who themselves have experienced the removal of their children at one time and have reunified to become a stable and productive family. Parents are referred to the program by DCS and Pima County Juvenile Court. This fiscal year, 93 families were served and 184 children benefited from this program. To date, this program has positively impacted 516 families and 1030 children. Most importantly, less than 1% of participants have returned to court supervision.
