Community Resources Program: For 40 years, Aviva's Community Resources Program has been an important resource for DCS staff to obtain everyday necessity items for foster children and vulnerable families in our community. The goal of this program is to bring dignity, hope and joy to these families. Our staff and volunteers work tirelessly to ensure that we make available basic necessity items. This past fiscal year, our program reached 2,200 children and 500 families in Pima County. We provided over \$19,000 in food cards, shoe and school uniform vouchers and supplemented this with in-kind donations of basic necessity items. In addition, we distributed 7,000 new and gently used clothing items; 5,000 pairs of socks, underwear, and diapers; 5,000 school supply items and backpacks; and 800 hygiene and cleaning kits. Our volunteers gave their time and talents to provide children with 500 beautiful handmade quilts valued at \$13,500 and 4,000 bags for kids valued at \$33,000. This program is supported entirely by community donations and grants. Our Life Book staff created 7 beautiful books that tell a child's story in a sensitive, accurate and age appropriate way. These books are done for children that will not be reunified with their parent and will be adopted. In addition, one of the agency's largest events is our Christmas on Tuesday Holiday Giveaway. Monetary contributions and in-kind donation of toys helped us serve over 2,300 foster children during Christmas 2018.

**Form 990, Part III, Line 4b:**

Supervised Visitation & Parent Aide Programs: Supervised visits and parent aide services are among the most important services that a family receives when they become involved with the Department of Child Safety (DCS). The goal of this program is to support and empower parents as they work to fulfill their DCS case plan requirements in order to reunify with their children. Under contract with the state, Aviva supervised 3,500 court-mandated visits for families in dependency. We served 80 families and 200 children.

---

### **Form 990, Part III, Line 4c:**

Parent Support Program: This program highlights the important role that parent peers play in helping families reunify and in preventing the recurrence of child abuse and neglect. Launched in 2011, it started as a postreunification support program for parents who at some point had their children removed from their care and subsequently were reunified. The goal is to reduce the rate of recidivism amongst reunified families. It has now expanded to assist families with an out-ofhome dependency and those receiving inhome services as part of a prevention strategy. Parents can attend a weekly support group or get individual mentoring. The program is run entirely by trained staff and volunteers who themselves have experienced the removal of their children at one time and have reunified to become a stable and productive family. Parents are referred to the program by DCS and Pima County Juvenile Court.
