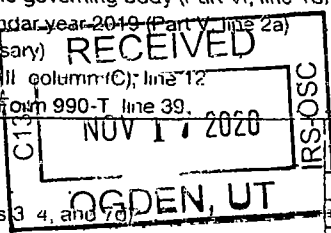

Founded in 2006, City Help Inc. of Phoenix dba The Phoenix Dream Center is a volunteer-driven 501(c)(3) nonprofit organization that provides community engagement assistance and life recovery housing and program services to the needy. Our goal is to provide services and support that seek to address the physical, social, emotional, and spiritual needs these individuals face.

Feeding, Housing, Clothing and Training Individuals: This program provides short and long term, no/low cost residential housing for individuals 18 years of age or older. It serves over 40,000 individuals each month and provides life recovery housing and program services to over 1,100 people each year. Many of the people we serve in our community have been homeless, addicted, incarcerated, or been victims of sex trafficking. Our goal is to provide services and support that address the physical, social, emotional, and spiritual needs these individuals face

Hope Wing. The Hope Wing provides a stable, safe environment for men and women (typically between the ages of 18 and 30) who have been caught up in the human trafficking pipeline and wish to get out, or who find themselves in crisis pregnancy. This free program is a therapeutic, transitional living program geared toward the spiritual, emotional and physical healing of these young people. It provides housing, food, clothing, medical care, legal assistance, counseling and training to assist in their transition to a normal, productive life. Although the program has its roots in the local community - 80% of the survivors being local residents - its scope is truly national, serving a diverse population from all across the country. The program currently has a 92% success rate.

Providing Food, Clothing & Services to the Needy of the Community:
Thrive: Serving families at risk of having their children removed and put into foster care due to a lack of food, clothing, beds and other items deemed necessary to create a safe living environment for the children.

Adopt-a-Block: Provides food and clothing at no cost to those within the community who need help and assistance. This equates to serving ~7,750 meals per week during community outreaches through food bags and hot meals, and providing ~4,500 pieces of clothing weekly to those in need.

Colorado City/Short Creek: Provides food, clothing and other services at no cost to those within the community who need help and assistance. This includes serving ~150 meals/month during community outreaches.

Line 11b: The Form 990 and Supporting Schedules are prepared in the Finance organization and then reviewed by the Executive Director and the Chief Financial Officer of the organization.

Line 12c: Conflict of Interest Statements are completed by all board members annually and reviewed by the Board of Directors.

Line 19: The organization's Articles of Incorporation ("Articles"), By-Laws, Conflict of Interest Policy, financial statements and 990's are made available to the public upon request.
