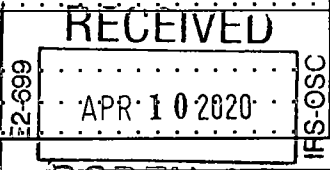

Temporary Shelter - Primarily engaged in providing (1) short term emergency shelter to victims of domestic violence; sexual assault, or child abuse and/or (2) temporary residential shelter for homeless individuals or families, runaway youth, and patients and families caught in medical crisis; operated shelters and/or subsidized housing using existing homes, apartments, hotels or motels for 83 clients and 3,746 bednights. The organization also received 416 calls through a crisis/hotline to provide emotional support and safety services. Information, referrals, civil advocacy assistance was provided to 82 individuals. Case management comprised of individual advocacy, transportation and medical assistance totaled 165 individuals which included 16 very young children and babies.
