CLIENTS MAY CHOOSE TO ENTER THE 120-DAY NEW LIFE PROGRAM FOR A CLIENT-CENTERED 12-STEP, FOCUSED, COGNITIVE-BEHAVIORAL CHANGING PROGRAM. RECOVERY PARTICIPANTS RECEIVE CASE MANAGEMENT SERVICES, PARENTING CLASSES, BUDGETING CLASSES, INDIVIDUAL AND GROUP COUNSELING, AND PARTICIPATION IN MANY SOCIAL ACTIVITIES AT THE MISSION AND THE COMMUNITY.
