DURING THIS REPORTING PERIOD, PPAU PROVIDED SERVICES TO MORE THAN 41,000 UTAHNS. THE COVID-19 PANDEMIC HAD A PROFOUND IMPACT ON THE NUMBER OF PATIENTS SERVED THROUGHOUT 2020. HOWEVER, PPAU REMAINED RESILIENT AND CONTINUED OFFERING ALL SERVICES AND KEPT ALL HEALTH CENTERS OPEN WITHOUT LOSING ANY STAFF.
