THE ONLY SUB-COMMITTEE IS THE EXECUTIVE COMMITTEE MADE UP OF THE PRESIDENT, VICE-PRESIDENT AND TREASURER. THE MANAGING DIRECTOR OF THE PANTRY (A PAID POSITION) KEEPS ALL CLIENT AND INCOMING AND OUTGOING FOOD RECORDS AND EACH MONTH PREPARES A CUMULATIVE SUMMARY FOR THE BOARD.
