Over 3,000 nights of safe housing were provided to those families and individuals fleeing abuse.</p> <p>New Facility - In 2017, the Organization entered into a lease agreement in order to construct and operate a new facility at Quinn's Junction. Peace House broke ground on the new building in September 2017, and the project was completed in August 2019. We completed the transition of the two existing facilities into the community campus in September 2019. In our new 42,000 square foot campus, Peace House is better equipped to provide holistic and appropriate care for the families seeking our assistance. Last year, Peace House provided 1,186 hours of therapy to adult survivors and 744 hours of therapy to children.
