<p>28</p> <p>In Fiscal Year 2020, Project Read served 50 students. During FY2020, Project Read transitioned to the new Test of Adult Basic Education (TABE 11/12). In addition, due to COVID restrictions in the fourth quarter, many students were unable to be tested. As such, while Project Read staff members conducted 56 assessments in FY2020, only 12 were posttests. 100 percent of the Project Read students who were retested using the Test of Adult Basic Education (TABE) increased their skills in either reading, language, or math (83 percent of those retested achieved a level gain a 1.0 grade-level equivalent (GLE) increase in either reading, language, or math), and the average gain was 0.5 GLE. In addition, in FY2020, 55 percent of Project Reads students achieved at least one literacy-related goal. Some of the goals accomplished by Project Read students in FY2020 include the following: 6 entered employment, 34 retained employment, 13 improved employment/received a raise, 9 improved employability skills, 10 achieved level gains, 7 were placed in post-secondary education/training, 1 obtained a food handlers permit, 3 increased their involvement in community activities, 3 increased their involvement in childrens educational activities, 7 improved their wellness and worked on attaining healthy lifestyles, 2 registered to vote, and 11 achieved other literacy-related goals. 141 volunteers donated 2,437 hours and helped Project Read serve 50 students who learned skills that improved not only their own personal lives but also the lives of their spouses and children (74 immediate family members impacted). Project Read could not fulfill its mission without the help of the dedicated volunteers who helped teach students and train tutors. Volunteers also helped with fundraising, public relations, events, website and technical support, and general office tasks.
