In spring of 2019, we launched NVVolunteerConnect, a free, Nevada-centric platform that matches nonprofit organizations with volunteers searching for service opportunities in their local communities. We partnered with UNLV graduate students whose research was used to develop the 2020-2023 Strategic State Service Plan. We aligned our annual signature event, the Governor's Points of Light Awards, with National Volunteer Month in April, leveraging a national conversation about volunteerism. We collaborated with our nonprofit partners to honor 190 exemplary volunteers across Nevada who received Governor's Volunteer Recognition Certificates from then Governor Brian Sandoval. We increased visibility of the impact that Nevada's young adults make in their local communities when we added a new youth category to the Governor's Points of Light Awards. We established LeaderCorps, an advisory council comprised of AmeriCorps State and AmeriCorps VISTA members to introduce a statewide day of service and to engage AmeriCorps members with AmeriCorps alumni. We employed a Compliance Coordinator, providing essential programmatic oversight for AmeriCorps Nevada subgrantees, ensuring the highest level of quality and oversight for Nevada Volunteers, subgrantees and programs.
