The primary focus for the Atlanta Land Trust in 2018 was building a sizable portfolio of permanently affordable housing. ALT was successful in cultivating relationships with for-profit and non-profit development partners who are committed to incorporating CLT units into their developments. At the end of 2018, ALT had 58 units in its pipeline which are expected to be delivered within the next year or two. ALT is pursuing three strategies for acquiring additional units, and will measure unit production within each of these: ALT-sponsored production -- Assemble land (or existing buildings) and partner with for-profit developers or regional nonprofit housing developers to complete construction (or rehabilitation) to ALT's standards. Municipally-sponsored production -- Position ALT to be the preferred buyer and long-term steward for affordably priced homes created through municipal mandate, municipal incentives or municipal investment. Fee-for-service stewardship -- Provide stewardship services on a fee-for-service for organizations that request ALT's assistance in marketing homes and maintaining the affordability, condition and security of those homes far into the future.

Form 990, Part III, Line 4b:

ALT worked to develop a program to provide effective stewardship services for the resale-restricted, owner-occupied homes to be developed by ALT and others. In 2018, the ALT Board of Directors took the critical step of hiring full-time staff. Carter Baldwin was engaged to represent ALT in the identification and selection of an Executive Director, who commenced employment on August 27. The Executive Director will make additional hires in 2019 focused on the development of a stewardship program.

Form 990, Part III, Line 4c:

ALT will create a favorable environment for CLT development by promoting public policy, community engagement and fundraising. In 2018 ALT worked to educate and build trust with communities around the Atlanta BeltLine where units will be created. This will allow ALT to begin to build a pipeline of prospective homebuyers who understand the benefits and tradeoffs associated with participation in a CLT. In 2018 ALT identified a necessary amendment to the Georgia Code and worked to build support around the issue which will allow CLT homeowners to receive homestead tax exemptions. ALT also worked in 2018 to begin to develop relationships with potential funders and was able to secure close to \$200,000 in grants.
