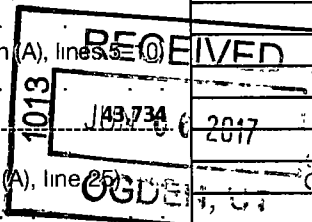

**02. Conflict of Interest Policy (Part VI, Line 12c) The Conflict of Interest policy is monitored by the Board on all decisions. All board members are independent from management and from all contractors.**

**03. CEO, Executive Director, Top Management Compensation (Part VI, Line 15a) The Board of Directors reviews and sets salaries for all employees based on performance reviews.**

**04. Other Officers or Key Employee Compensations (Part VI, Line 15b) The Board of Directors reviews and sets salaries for all employees based on performance reviews. No officers or board members are compensated.**
