UNCOM has been an operating partner of the Zilber Neighborhood Initiative (ZNI) since 2008 and currently works with Clarke Square Neighborhood Initiative, Layton Boulevard West Neighbors, Lindsay Heights/Walnut Way Conservation Corporation, and Local Initiatives Support Corporation Milwaukee UNCOM participates in the operating partner initiatives and supports ZNI partners in various initiatives that encompass the capacity building priorities of leadership, collaboration, sustainability, innovation, and public policy UNCOM became a partner of the Medical College of Wisconsin Violence Prevention Initiative in 2010 UNCOM's Violence Prevention Initiative is funded by the Healthier Wisconsin Partnership Program to develop leadership, capacity, and programs in UNCOM neighborhoods to effectively engage communities in the prevention of youth violence This program is developing both youth and adult leaders at the community level through participation in Parent Advisory Councils and Youth Leadership Councils UNCOM has managed its successful Youth Jobs Programs since 2008 resulting in a case management model for foster care, out-of-school at-risk and in-school youth Our programming is funded by the State of Wisconsin, Milwaukee Area Workforce Investment Board and Helen Bader Foundation Youth participants throughout the city of Milwaukee and from UNCOM agencies receive specialized training in life and employability skills as well as case management services, in order to complete high school and continue on with post-secondary education or become employed UNCOM also serves as publisher of The Milwaukee Neighborhood News Service Milwaukee NNS is a multimedia website that provides objective, professional reporting on urban issues in 17 Milwaukee neighborhoods NNS offers comprehensive, multimedia coverage of issues such as education, public safety, economic development, health and wellness, arts and recreation, employment, youth development and housing that are important to the people who live and work in the Milwaukee neighborhoods The site offers neighborhood residents and community organizations the opportunity to post upcoming events, comment on content and submit articles on local activities and issues NNS content also is available for local news organizations to republish with credit to the news service
