UNITED WAY OF LEWIS COUNTY IS CURRENTLY DEVELOPING STRATEGIES THAT SERVE BOTH CHILDREN AND THEIR PARENTS INTENTIONALLY AND SIMULTANEOUSLY, LEADING TO POSITIVE OUTCOMES FOR FAMILIES.

CHILDREN ARE MORE LIKELY TO THRIVE WHEN THEIR PARENTS ARE THRIVING. FOR 24.5% OF YOUTH IN LEWIS COUNTY, POVERTY IS IMPEDING THEIR EDUCATIONAL SUCCESS.
