WE ADVOCATED ACROSS SECTORS WITH THE WASHINGTON STATE DEPARTMENT OF SOCIAL AND HEALTH SERVICES, (DSHS), UNITED WAYS OF KING AND PIERCE COUNTIES, AS WELL AS LOCAL COMMUNITY SERVICE ORGANIZATIONS TO STRENGTHEN THE WORKFIRST/TEMPORARY ASSISTANCE TO NEEDY FAMILIES OR TANF PROGRAM FOR LOW-INCOME HOUSEHOLDS. TANF IS SUPPOSED TO BE A SHIELD TO PROTECT FAMILIES FROM EXTREME HARDSHIP, AND A BRIDGE TO FINANCIAL SECURITY AND A BETTER LIFE. HOWEVER, OVER THE LAST DECADE WASHINGTON STATE HAS CUT OVER \$220 MILLION FROM WORKFIRST/TANF THROUGH POLICY CHANGES THAT HAVE RESULTED IN TENS OF THOUSANDS OF FAMILIES LOSING BASIC SUPPORT. AS A RESULT OF THESE CUTS, WE DISCOVERED THAT BLACK AND AMERICAN INDIAN FAMILIES WERE BEING CUT OFF WORKFIRST/TANF AT HIGHER RATES THAN OTHER RACIAL GROUPS AND DETERMINED IT IS A SYMPTOM OF A LARGER PROBLEM OF SYSTEMIC RACIAL BIAS IN HUMAN SERVICES DELIVERY SYSTEMS. WE WENT TO WORK ON INVESTIGATING THIS ISSUE FURTHER AND BUILT A COMMUNITY COALITION TO ENSURE POLICY AND PROGRAM CHANGES WERE IMPLEMENTED AT DSHS TO ENSURE ALL OF OUR CLIENTS HAVE THE RESOURCES THEY NEED TO MEET THEIR BASIC NEEDS, ESPECIALLY WHEN THEY FALL ON HARD TIMES. THE CENSUS IS A MECHANISM THAT COMMUNICATES TO FEDERAL AND STATE STAKEHOLDERS THE NEEDS OF OUR COMMUNITY, FROM HEALTHCARE TO EDUCATION AND OTHER HUMAN SERVICES. ITS RESULTS HELPS TO DETERMINE REPRESENTATION IN CONGRESS, AS WELL AS ALLOCATION OF FUNDING FOR MUCH NEEDED SERVICES. WE ENGAGED OUR CLIENTS AND COMMUNITY MEMBERS, WHO INCLUDED LOW-INCOME RESIDENTS, PEOPLE OF COLOR, AND IMMIGRANTS & REFUGEES TO HELP THEM UNDERSTAND THE BASIS FOR THE CENSUS COUNT AND HOW TO PREPARE TO PARTICIPATE IN IT TO ENSURE AN ACCURATE COUNT. WE PROVIDED A BROAD RANGE OF NONPARTISAN VOTER EDUCATION ACTIVITIES THROUGH TABLING, OUTREACH AND COMMUNITY EVENTS, EDUCATING PEOPLE ON THEIR RIGHT TO VOTE, AS WELL AS HELPING GET THEM REGISTER TO VOTE.
