Housing & Energy Services The Energy Assistance Program provides help to low-income households in making their home heating bills more affordable, avoid shutoff of utilities during winter months, ensuring warm healthy households for children, the elderly and disabled as well as low-income families and individuals. Emergency Shelter Grants Program and Emergency Shelter Assistance Program provide the only emergency shelter for homeless families in Kittitas County and takes referrals from the domestic violence shelter. Assistance to Veterans will be delivered through a variety of services to address current gaps in continuum of care for this group of individuals. In 2018, over 276 low income veteran families were screened and/or served in the five county area.
