THE GOAL OF OUR WEATHERIZATION PROGRAM IS TO IMPROVE THE QUALITY OF LIFE OF OUR CLIENTS BY REDUCING THEIR ENERGY AND BUDGET BURDENS, ALLOWING THEM TO BECOME MORE SELF-SUFFICIENT.
