HIGH QUALITY EARLY LEARNING LAYS A FOUNDATION FOR A STRONG FUTURE. BUT TOO MANY YOUNG CHILDREN DON'T GET A CHANCE TO BUILD THE FUNDAMENTAL BRAIN ARCHITECTURE THAT ALLOWS THEM TO THRIVE IN SCHOOL AND IN LIFE. IN 2020, CHILDREN'S ALLIANCE SUPPORTED EFFORTS TO INCREASE THE REIMBURSEMENT RATE FOR WORKING CONNECTION CHILD CARE AND EXPAND ACCESS TO THE STATE FUNDED PRESCHOOL PROGRAM, AS WELL AS KEEPING FOCUS ON LONGER TERM EFFORTS TO ADDRESS BARRIERS TO HIGH QUALITY CARE, WHILE PRESERVING AND EXPANDING THE DIVERSITY OF THE CHILD CARE WORKFORCE. THIS WORK RESULTED IN \$47 MILLION IN NEW STATE FUNDING FOR EARLY LEARNING.
