Residential and Home Care Services: Cascade Connections residential services provides a wide range of services varying from a few hours a week to 24-hour care. Supports include daily living skills, personal care, shopping, medical appointments, respite services etc Customers are referred to Cascade Connections through the Developmental Disabilities Administration, Aging and Adult Services, and private pay contracts. Customers range in age from 6-years old to over 70.
In 2017 the number of customers served in our Residential and Home Care services were as follows:
Cascade Christian Home (founding home of our organization): 8 residents
Supported Living: 27
Pine Street Adult Family Home: 7 (prior to October 2017)
Home Care Services: 51 customers.

4b (Code:) (Expenses \$ 2,075,436 including grants of \$) (Revenue \$ 2,400,417)
Vocational Services: Cascade Connections served a total of 178 individuals with disabilities in 2017. Our customers range from transition students coming out of high school at 21 to those approaching retirement in their 70's. The customers of CC are referred to us through Division of Vocational Rehabilitation, Developmental Disabilities Administration, and Department of Services for the Blind. Cascade Connections serves a wide variety of individuals who have a variety of skills and abilities as well as support needs. CC works with hundreds of local businesses throughout Whatcom County assisting them to increase the diversity in their workforce. We offer information for local employers, set up informational interviews and working interviews, negotiate reasonable accommodations if needed, and provide on-site training. CC belongs to the Lynden, Ferndale and Bellingham Chamber of Commerce, The Society of Human Resource Management and the Lions Club.
Cascade Connections has created 872 jobs since 1994, 43 of them in 2017. Cascade Connections commercial operations employed a total of 70 people with disabilities on their crews in 2017. Those individuals earned a total of \$453,414 during the year.

Training Services. Cascade Connections Training Department, created in 2012, offers many classes to both CC staff, other organizations, community members and families. Classes include: Orientation, Health and Safety, CPR/FA, Right Response, Population Specific Trainings, CORE, Continuing Education Units, and Leadership. In addition, CC offers Prometrics training on site at our training center on designated testing dates. Cascade Connections has been able to create customized trainings to meet the needs of our customers and our community.
In 2017 a total of 10,836 training hours were provided to 247 staff, 58 individuals from other agencies and 45 community/family members participated in training. 44 Prometric testing date were hosted by CC with a total of 490 individuals testing in 2017.
