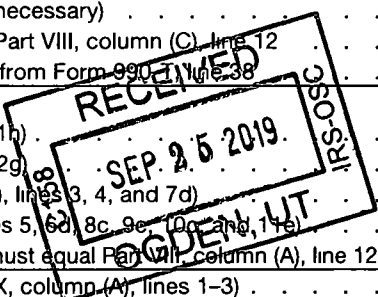

Cascade Connections' mission is : Empowering individuals with disabilities to enhance their quality of life. Cascade Connections achieves its mission through its statement of values, which include: Service Excellence, Integrity, Empowerment, Competencies, Christian Leadership, Servant Leadership, Equal Opportunity, Individualized Services, and Community.

Residential and Home Care Services: Cascade Connections Residential Services provides a wide range of services, varying from a few hours a week to 24-hour care. Supports include daily living skills, personal care, shopping, medical appointments, respite services, etc. Customers are referred to Cascade Connections through the Developmental Disabilities Administration, Aging and Adult Services, and private pay contracts. Customers range in age from 6-years old to over 70.

In 2018, the number of customers served in our Residential and Home Care services were as follows: Cascade Christian Home (founding home of our organization): 8 residents; Supported Living: 29 customers; Home Care Services: 62 customers.

Vocational Services: Cascade Connections Vocational Department served a total of 208 individuals with disabilities in 2018. Our customers range from transition students coming out of high school at 21 to those approaching retirement in their 70s. The customers of CC are referred to us through Division of Vocational Rehabilitation, the Developmental Disabilities Administration, Department of Services for the Blind, and Foundational Community Supports. Cascade Connections serves a wide variety of individuals who have varieties of skills and abilities as well as support needs. CC works with hundreds of local businesses throughout Whatcom County, assisting them to increase the diversity in their workforce. We offer information for local employers, set up informational and working interviews, negotiate reasonable accommodations if needed, and provide on-site training when needed. Cascade Connections created a total of 50 new positions for people with disabilities in Whatcom County in 2018. This brings our grand total of employment placements since the start of our organization to 915 jobs.

Cascade Connections Commercial Operations employs a total of 65 individuals with disabilities. CC provides janitorial services for the US Border Crossings, the Department of Homeland Security, the City Of Bellingham and many local businesses and non-profit organizations. These crew members worked over 26,000 hours and earned \$407,756 in 2018

Training Services: Cascade Connections Training Department, created in 2012, offers many classes to both CC staff, other organizations, community members and families. Classes include: Orientation and Safety, CPR/First Aid, Right Response, Population Specific trainings, DD Core, and Continuing Education courses. In addition, CC offers Prometrics testing on site at our training center on designated testing dates. Cascade Connections has been able to create customized trainings to meet the needs of our customers and our community.

In 2018, a total of 9,866 training hours were provided to 248 staff and 81 individuals from the community or other agencies. 61 Prometrics testing dates were hosted by CC, with a total of 396 individuals testing in 2018.

After the 990 is reviewed, all questions answered, and changes have been made if necessary the Board Treasurer signs the 990 and it is mailed to the IRS.

990 Part VI, line 12c : The organization regularly and consistently monitors and enforces compliance with the conflict of interest policy. All employees and Board members are required upon initial hire/involvement with the agency to sign the conflict of interest statement. Whenever any business is conducted with an outside firm the Board staff are asked if they have any relationships that could be construed as being a conflict of interest. If they do, they are required to not be involved with the bidding process or involved with the process that determines who will get the job.

990 Part VI, lines 15a & 15b : The process for determining compensation for the management staff excluding the Executive Director is set according to an agency pay scale. This pay scale is determined by looking at the description of position and finding out what other like agencies are paying for those job positions and responsibilities. Other factors are figured into this determination, such as what the agency is getting paid in contract to provide those services and looking at fringe benefits and whether other agencies are offering comparable benefits or not. The Executive Director and the agency Finance Director make a pay scale recommendation to the Finance Committee of the Board of Directors. The Finance Committee then studies the information and recommends to the full Board of Directors who give the final approval for any changes. The Executive Director's pay is determined by a like position and job description comparison performed by the Board of Directors. Any changes to the Executive Directors pay and/or benefits are discussed and voted on by the full Board. It is agency procedure that no change to the Executive Director's pay may be made without written approval from the Board of Directors.
