CHINOOK STAFF PROVIDED INDIVIDUALIZED WORK SCHEDULES ALONG WITH CONTINUOUS GUIDANCE AND OVERSIGHT. UNFORTUNATELY, LEGISLATIVE CHANGES IN 2015 REQUIRED SHELTERED WORKSHOPS STATEWIDE TO BE PHASED OUT BY 2019. THIS ACTION INSTIGATED A PHASE-OUT PERIOD FOR THE DEPARTMENT. AT THE TIME OF CLOSURE, SUPPORTED PRODUCTION EMPLOYED NINE PEOPLE WITH MODERATE DISABILITIES WHO PERFORMED WIRE CRIMPING, PACKAGING, AND COUNTING TASKS.
