Bellwether Housing, founded by the Downtown Seattle Association in 1980, is the largest private nonprofit provider of affordable apartments in King County, Washington. Our residents are low-wage working people, low-income seniors, and those with special needs. The annual household incomes range from \$18,000 to \$50,000 depending on household size (30% to 60% of area median income for King County). Average annual household income for Bellwether residents in 2016 was approximately \$25,083.
