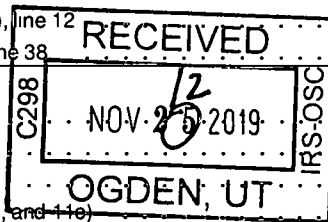

**Apprenticeship Opportunity Project - In 2018, ANEW assisted 660 individuals with financial support to overcome a barrier to employment or retention in their apprenticeship. These barriers included items like childcare, utilities and rent, tools and equipment, tuition and books, and transportation related costs. ANEW is able to provide assistance to any individual who is interested in entering an apprenticeship or a family wage career in the construction industry. ANEW assists these individuals for the first two years of their apprenticeship/employment.**

**Pre-apprenticeship Programs - In 2018, ANEW trained 180 individuals in our pre-apprenticeship programs for family wage careers in the construction industry. Our pre-apprenticeship program consists of approximately 250 hours of training which includes trades math, physical fitness, basic construction concepts, construction career exploration and soft skills employment readiness. ANEW places almost 80% of graduates in family wage careers paying over \$20.00 per hour.**

**RISE Up Program - RISE Up (Respect, Inclusion, Safety and Equity in the construction trades) is a respectful workplace campaign aimed at creating an inclusive environment in the construction trades. The construction trades is predominantly white male and has historically not been accepting of women, people of color, or LGBTQ communities. This educational campaign provides materials to contractors and public entities to reduce bias and educate employees on the importance of inclusion and the impact not having a respectful worksite has on the safety and productivity of the job site.**
