Upon arrival it became clear that neither the 2016-17 or 2017-2018 Form 990 had been completed, partially due to extended chemotherapy treatment of the then Finance Manager. Following the repeatedly delayed completion of the 2018 audit in mid-September 2019, the new Finance Team and New Horizons Ministries completed and submitted the 2017 (2017-2018) Form 990 on September 30, 2019, and is scheduled to complete and file this 2016 (2016-2017) Form 990 on November 15, 2019. We have also filed an extension for the 2018 (2018-2019) Form 990. All financial processes have been entirely revamped and we have clear methods of completing the Form 990 in compliance.
