IN TRANSITIONING TO VIRTUAL ENGAGEMENT DURING COVID-19, HABITAT SKC HELD IT'S FIRST VIRTUAL "BEYOND THE BUILD" LUNCHEON IN JUNE RAISING OVER \$1.6 MILLION AND FEATURING FORMER SEATTLE SEAHAWK DOUG BALDWIN AND MATTHEW GARDNER, WINDERMERE'S CHIEF ECONOMIST.
