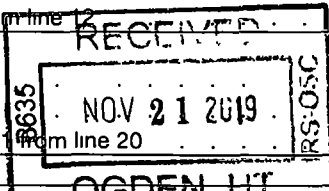

Over 3,768 wardrobes were given out in FYE 06/30/2019 through the dedication of more than 110 volunteers working over 8,300 hours. CFK receives no government funding and operates 100% on community support from individual and corporate giving, special events, and grants from community and corporate foundations.
