Since 1984, CFK has provided free clothing to income eligible children in Snohomish County, WA, so they may arrive at school ready to learn. Over 4,149 wardrobes were given out in FYE 06/30/2020 through the dedication of more than 110 volunteers working over 6,700 hours. CFK receives no government funding and operates 100% on community support from individual and corporate giving, special events, and grants from community and corporate foundations.
