DIVERSION OFFERS ONE-TIME FINANCIAL ASSISTANCE AND OTHER SHORT-TERM SERVICES, SUCH AS MEDIATION WITH A LANDLORD OR RELATIVE, TO HELP FAMILIES MAKE A SMOOTH AND SAFE TRANSITION OUT OF HOMELESSNESS. CONSIDERED A "LIGHT TOUCH" APPROACH, DIVERSION IS A LOW-COST ALTERNATIVE TO DEEPER INTERVENTIONS, THUS FREING UP RESOURCES THAT CAN BE INVESTED TO HELP MORE FAMILIES IN NEED OF STABLE HOUSING. AFTER ALREADY IMPLEMENTING DIVERSION PILOTS IN KING AND PIERCE COUNTIES, BUILDING CHANGES CONTINUES TO INTRODUCE DIVERSION TO NEW COMMUNITIES AROUND THE STATE, INCLUDING ADAMS, CHELAN, CLARK, DOUGLAS, GRANT, KITTITAS, OKANOGAN, SPOKANE, AND WHATCOM COUNTIES. BUILDING CHANGES ALSO IS SPREADING DIVERSION TO DIFFERENT SYSTEMS. BUILDING CHANGES LAUNCHED A PILOT IN PIERCE COUNTY IN 2017 THAT TRAINS CALL CENTER STAFF AT SOUTH SOUND 2-1-1 (A REGIONAL HEALTH AND HUMAN SERVICES INFORMATION AND REFERRAL LINE) IN THE SKILLS OF DIVERSION SO THEY CAN OFFER IT TO CALLERS OVER THE PHONE. ANOTHER OF BUILDING CHANGES PILOTS IN PIERCE COUNTY IS TRAINING MATERNITY SUPPORT PROFESSIONALS (REGISTERED NURSES, COUNSELORS, REGISTERED DIETICIANS) TO OFFER DIVERSION TO THE LOW-INCOME PREGNANT AND POST-PARTUM WOMEN THEY ARE SERVING. RAPID RE-HOUSING. BUILDING CHANGES IS EXPANDING RAPID RE-HOUSING TO SERVE MORE FAMILIES. RAPID RE-HOUSING IS A PRIMARY SOLUTION IN WASHINGTON STATE FOR HELPING FAMILIES PUT HOMELESSNESS BEHIND THEM. IT PROVIDES SHORT-TERM RENTAL SUBSIDIES AND CASE MANAGEMENT TO FAMILIES SO THEY CAN MOVE QUICKLY FROM HOMELESSNESS TO STABLE HOUSING.
