Food Distribution - The Food Bank, which operates like a grocery store, distributes food to those seeking assistance from seven Seattle zip codes in the neighborhoods of Ballard, Magnolia, Queen Anne, South Lake Union, Fremont, Phinney Ridge, Greenwood, Greenlake, and Licton Springs. The Food Bank and home delivery programs distributed more than 2 million pounds of food over the course of the year. The Organization had 56,559 visits and deliveries, nearly 50% more than the 2018-19 fiscal year. While the overall number of people served is lower, more people received assistance with rent this year. This year the Organization's efforts have been focused on meeting the increased demand due to COVID-19 as well as ensuring the safety of their clients, volunteers and staff during this crisis.
