LASA provides housing to families experiencing homelessness. Housing included emergency shelter of 90 days or less, and permanent housing including support services. Housing services come with the provision of utilities, furnishings, case management and other services. LASA provides holistic services to families in our housing programs. To do this, we include services that go beyond housing and essential needs to services that build community and help families establish their homes. These services included our third annual Santa Cruise with free Santa pictures for families, food for Thanksgiving and Christmas meals, and gifts for all family members. Extra presents were also provided to over a dozen families not in LASA housing programs. Each family entering housing was provided a box of cleaning supplies and access to household goods to setup their homes. Two of our properties have community gardens where tenants grow flowers, fruits and vegetables. These services are supported by a number of local businesses, civic and religious groups and individuals. LASA's Client Services Center opened to provide critical services to the community. 113 households facing water disconnection were served with water assistance. LASA continued to assist households with referrals to the NW furniture bank, provided critical items such as hygiene products, diapers, coats and more via our Essential Needs Closet, and made referrals to many community services. LASA also opened a computer lab accessible to families in housing and others accessing our services.
