They assist survivors in understanding the options available to them. In cases where a woman's health and safety is at substantial risk, ELAP seeks out teams of attorneys from law firms and companies to provide full representation to the DV survivor

Clinics, Workshops, and Lectures - ELAP operates legal clinics staffed by intake and attorney volunteers. Clients receive thirty to forty-five minute appointments for free legal advice and consultation on their civil legal issues

Client Plus and Direct Representation - Limited individual assistance beyond the advice and counsel provided at the legal clinics is available from volunteer attorneys.
