ELAP's Domestic Violence Staff and Volunteer Attorneys provide extensive advice and limited representation for survivors of domestic violence. They assist survivors in understanding the options available to them. In cases where an individual's health and safety is at substantial risk, ELAP seeks out teams of attorneys from law firms and companies to provide full representation to the domestic violence survivor

Clinics, Workshops, and Lectures - ELAP operates legal clinics staffed by intake and attorney volunteers. Clients receive appointments for free legal advice and consultation on their civil legal issues

Client Plus and Direct Representation - Limited individual assistance beyond the advice and counsel provided at the legal clinics is available from volunteer attorneys. This may involve writing letters, reviewing documents, and making phone calls for a client. This also includes the Wills Project where clients receive basic documents such as wills, physician's directives, etc. Direct representation is provided in some cases by volunteer attorneys, which involves providing more complete legal services at no charge to the client
