During 2018, good reached families through 165 programs and sites in King, Snohomish, Kitsap and Pierce counties. EBC is not only an organization that helps kids - it's an organization that allows the community to help kids. Volunteers donate an average of more than 2,700 hours each month. EBC continues to help more children, 12,370 (unduplicated) children received goods in 2018. In 2018, EBC distributed thousands of essential goods, including 1,046,453 diapers, 5,737 cans of infant formula, 8,307 Big Bundles of clothing to kids and expectant mothers, 1,670 car seats and 13,568 baby food meals.
