Christmas
This is one of our largest expenses. Most of the donated toys are for younger children. We have to purchase most of the items for children age 11 and above. A grant by the Puyallup Tribe was specified for the purchase of NEW TOYS only so rather than repair what we bought all new for children ages 11 and up. We served over 5000 children with this donation. Milgard Foundation also included \$10,000 for the purchase of new clothing and gift cards for children 13-15.

Birthdays, Easter and Back to School
This is the 2nd largest expense. We operate year round to ensure no child goes unrewarded on their special days. We offer gifts, games or movies, party supplies, cake mix and frosting and all of the gift wrap. We also prepare more than 1600 Easter baskets each year. This year we make 1610 baskets. 2017 Back to school included new backpacks with supplies for 843 children. Our birthdays served in 2017 with 373 with an average of \$125.00 spend on each child. Most of the \$125 comes from in-kind donations and no expenses are required.

Toy Restoration
This includes all of the cost to repair and refurbish the used items we receive. Included are cleaning supplies, packaging materials and shrink wrap. Additionally this is the money we use to buy spare parts to make complete toys.
