100% of Companis program expenses are spent on one program: providing volunteer professionals, including support assistance, to local 501(c)(3) organizations in order to fill gaps in agencies serving our neighbors in need of advocacy, support and encouragement. In 2017, Companis made 81 placements of volunteer professionals with 46 nonprofit agencies in the greater Seattle/King County area. Those placements resulted in \$1.2 million in value for our partner organizations. Companis enhances our volunteers' experience through professional development, group meetings, workshops, event retreats and other activities that balance their active service with reflection. Companis also offers executive, strategic and board leadership assistance to some of our partner agencies. In this way, Companis strengthens organizations engaged in human service and social justice work and created an engaged crop of community service volunteers.
