Housing Solution Center (HSC) is a one step access point for all publicly funded emergency shelter, homelessness prevention and housing programs for people who are homeless in Clark County. At HSC we determine the best-fit program for someone's needs and connect them to that partnering agency's program. We also help connect people to other forms of assistance they might need, such as employment training and health insurance.

4b (Code:) (Expenses \$ 156,049 including grants of \$ 135,169) (Revenue \$ 135,169)

Homeless Management Information System (HMIS) - The Council for the Homeless takes the lead in data collection through a web-enabled Homeless Management Information System which links homeless programs and gathers long-term unduplicated information. To supplement this data, the Council for the Homeless directs a biennial "point in time" survey of people who are homeless or at risk.

Winter Hospitality Overflow Shelter (WHO) provides safe shelter during the winter months to families and individuals experiencing homelessness. WHO guests are offered a warm place to sleep, a hot shower, a meal, and the welcome and warmth of a community working to address the most basic of human needs.

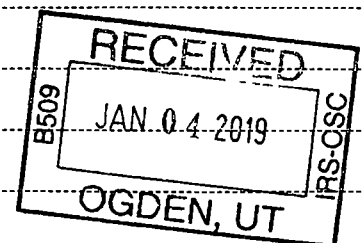
