The Mockingbird Youth Network (MYN) is a powerful, state-wide coalition of young people aged 13-24 who have been impacted by foster care. The program focuses on youth leadership development, civic engagement, system reform and educating the public on foster care and homeless youth issues. Youth Advocates Ending Homelessness (YAEH) engages youth 13-24 throughout King County in working to develop and advocate for plans to prevent and end youth homelessness. In 2017, over 400 youth and young adults participated in activities such as local chapter meetings, leadership trainings and community engagement projects. There are seven chapters, located in Seattle (one MYN and one YAEH chapter), Tacoma, Everett, Olympia, Yakima and Spokane, and each chapter's youth are actively engaged in shaping a reform agenda. Youth meet regularly with policymakers, participate on issue work groups, speak at community forums and offer creative ideas to improve child welfare systems based on their own experiences in foster care.

Form 990, Part III, Line 4b:

The Mockingbird Family Model (MFM) is an innovative foster care delivery model created by The Mockingbird Society in 2004. The MFM creates an extended "hub" of family support that improves safety, stability and permanency for children and adolescents in the child welfare system using a constellation framework. The MFM has been implemented in Washington, Kentucky, the District of Columbia, and the United Kingdom. In Washington State, 130 families and 406 children and youth participated in this model in 2017.

Form 990, Part III, Line 4c:

The Mockingbird Society's Public Policy and Communications program advocates for upstream system reform in collaboration with policymakers, child welfare advocates, service providers and constituents impacted by foster care and youth homelessness. In 2017, our advocacy efforts helped (1) form the new Department of Children Youth & Families, bringing together state-wide services that serve youth and families across the state under one roof, (2) improved opportunities and access to independence by providing support for foster youth to obtain drivers licenses, permits, and insurance, (3) improved educational outcomes for foster youth by requiring school credits to transfer when a youth changes schools, (4) secured funding for a two-county demonstration and evaluation for what happens when youth receive legal representation within 72 hours of entering foster care, and (5) secured funding for MFM in the biennium.
