Mockingbirds Youth Programs is a powerful, state-wide coalition of young people aged 13-26 who have been impacted by foster care or who are experiencing or at risk of experiencing homelessness. The program focuses on youth leadership development, civic engagement, system reform and educating the public on foster care and homeless youth issues. In 2018, over 300 youth and young adults participated in activities such as local chapter meetings, leadership trainings and community engagement projects. There are seven chapters, two are located in Seattle, and one in Tacoma, Everett, Olympia, Yakima and Spokane. Each chapter's youth are actively engaged in shaping an annual systemic reform agenda. Youth meet regularly with policymakers, participate on issue work groups, speak at community forums and offer creative ideas to improve child welfare and homeless youth systems based on their own experiences in foster care.

---

## **Form 990, Part III, Line 4b:**

The Mockingbird Family Model (MFM) recreates the positive qualities and resources found in naturally thriving families in part through the role of the Hub Homean experienced and licensed foster care family who provides support to other foster families participating in MFM. The community network created by MFM focuses on the individual needs of its youth by ensuring foster parents are highly skilled and effective in providing the best care for our community's youths. When foster families are developed and brought into a supportive community like MFM, social workers are more able to focus on successful reunifications with family and loved ones and other meaningful permanency options for our young people. In 2018, there were 164 Mockingbird Families with 363 kids, foster parents were retained at 94% (compared with the states average of 63%), over 30,000 hours of respite care was provided which helps with retention and placement stability. Outside of Washington, we had an additional 480 Mockingbird Families with over 600 kids. We now license MFM in Washington, California, New York, Australia, the United Kingdom, and Canada.

---

### **Form 990, Part III, Line 4c:**

The Mockingbird Society's Public Policy and Advocacy program advocates for upstream system reform in collaboration with policymakers, child welfare advocates, service providers and constituents impacted by foster care and youth homelessness. In 2018, took lead on the following issues: SB 6274 (Passport to College Scholarship) we ended eligibility discriminations, including those against tribal and federal foster youth and state foster youth placed out-of-state. Now every foster and homeless youth in Washington can access this scholarship. SB 6222 (Strengthen Extended Foster Care) we fixed loopholes that excluded youth in the Juvenile Rehabilitation Administration (JRA), changed eligibility to allow young people to opt or out as many times as needed until age 21. SB 5596 (End the jailing of youth for non-criminal status offenses, including truancy and running away) - we made significant progress on this issue, educating legislatures and developing champions.
