With funding from the Legal Services Corporation, ALSC took in applications from 57 households during 2015, providing legal advice or representation to 26 of those households containing 51 individuals. During the course of the year, including carryover and new cases, 98 households received LSC-funded assistance from ALSC. Additionally, ALSC used LSC funds to develop and distribute self help legal resources through our website and through conducting multiple community legal education clinics. It is estimated these resources provided assistance to thousands more low-income households.

4b (Code) (Expenses \$ 500,858 including grants of \$) (Revenue \$ 34,673)

With a designated Legislative grant from the state's Department of Commerce, Community, and Economic Development, ALSC provided legal advice and/or representation in non-criminal matters to additional indigent Alaskans throughout the state.

WITH FUNDING FROM DHSS GRANTS (COMMUNITY INITIATIVE-FAMILIES AT RISK, TITLE III-NTS AND FAMILY CAREGIVER), ALSC TOOK IN APPLICATIONS FROM 805 HOUSEHOLDS, PROVIDING LEGAL ADVICE OR REPRESENTATION TO 438 OF THOSE HOUSEHOLDS CONTAINING 849 INDIVIDUALS. THERE WERE 568 OPEN CASES DURING THE YEAR.
