SOCIAL JUSTICE PROGRAM: THE SOCIAL JUSTICE PROGRAM PROVIDES A WIDE RANGE OF SERVICES AND TRAININGS TO IMPROVE UNDERSTANDING OF THE CAUSES AND EFFECTS OF INTERPERSONAL VIOLENCE, RACISM, SEXISM, HOMOPHOBIA AND OTHER FORMS OF OPPRESSION. COURSES INCLUDE THE 40-HOUR REQUIRED TRAINING FOR ALL PROVIDERS OF DOMESTIC VIOLENCE AND SEXUAL ASSAULT SERVICES (PAID AND VOLUNTEER). TRAININGS WERE PROVIDED TO LOCAL EMPLOYERS, COMMUNITY BASED ORGANIZATIONS, AND THE GENERAL PUBLIC. THE SOCIAL JUSTICE PROGRAM EQUIPS OUR COMMUNITY WITH THE RESOURCES AND SKILLS NECESSARY TO CREATE A MORE JUST, EQUITABLE WORLD. IN MARCH 2020, SERVICES WERE ADAPTED TO BE PROVIDED VIRTUALLY, AND RESTARTED AGAIN IN MAY OF 2020. TOTAL SERVED: 2,044 IN 40 TRAININGS AND FIVE COMMUNITY EVENTS. YOUTH AND CAMP WESTWIND SCHOLARSHIPS: THE YWCA OF GREATER PORTLAND AGAIN PROVIDED SCHOLARSHIPS TO ENSURE LOW INCOME URBAN YOUTH HAVE ACCESS TO THE OFTEN LIFE-CHANGING OPPORTUNITIES THAT CAMP WESTWIND HAS PROVIDED FAMILIES AND YOUTH FOR DECADES. YWCA LEADERSHIP CONTINUES TO WORK WITH CAMP WESTWIND LEADERSHIP TO ENSURE CAMP STAFF ARE TRAINED AND SUPPORTED IN SOCIAL JUSTICE THEORY AND APPLICATION, PROVIDING CULTURALLY RESPONSIVE SERVICES AND EXPERIENCES. THE YWCA ALSO PROVIDES SCHOLARSHIPS TO CHILDREN INVOLVED IN ITS VARIOUS PROGRAMS TO ENCOURAGE THEIR ENGAGEMENT IN THE ARTS, SCHOOL ATHLETICS, AND SUMMER CAMPS: ALL KNOWN TO ENCOURAGE THE SOCIAL, EMOTIONAL, AND INTELLECTUAL DEVELOPMENT OF CHILDREN WHO BECAUSE OF POVERTY LACK THESE OPPORTUNITIES.
