## **CONSTITUTION OF THE ARC PORTLAND METRO**

### **ARTICLE I NAME**

The name of this organization shall be: The Arc Portland Metro, (Amended 2020) hereinafter referred to as “The Arc”.

### **ARTICLE II MISSION**

#### **SECTION I:**

The mission of The Arc is to affirm the worth and dignity of all individuals and families impacted by developmental disabilities. The Arc offers advocacy, support, and services designed to enhance their right to make choices, receive an appropriate and adequate share of community resources, and make important contributions to society.

#### **SECTION IA:**

Mission Statement: The Arc provides advocacy, support and services to children and adults with intellectual and developmental disabilities and their families.

#### **SECTION 2:**

The Arc shall not engage in partisan activities, endorse or contribute to any political party or candidate seeking public office, or take a position on matters before an elected body or government agency other than on matters consistent with a purpose among those described in Section 1. This prohibition shall not be interpreted to deny individual members of The Arc, its officers and directors, or its staff their right to participate as individuals or speak on matters of personal concern.

#### **SECTION 3:**

The Arc is a nonprofit, nonpolitical, nonsectarian organization. No part of any earnings shall benefit any member, and no officer or director of The Arc’s Board of Directors shall receive any compensation for his or her services as an officer or director of same.

**ARTICLE III**  
**ADDRESS**

**SECTION 1:**

The official address of The Arc shall be that designated by the Board of Directors.

**SECTION 2:**

The registered office of The Arc required by the Oregon Nonprofit Corporation Law to be maintained in the State of Oregon may be, but need not be, identical with the principal office in the State of Oregon, and the address of the registered office may be changed from time to time by the Board of Directors upon compliance with statutory requirements.

**ARTICLE IV**  
**MEMBERSHIP**

**SECTION 1:**

There shall be one class of member in good standing of The Arc which shall consist of all people interested in the mission of The Arc, and whose dues are not delinquent.

**SECTION 2:**

Each member shall be classified as member of the local, state and national levels of The Arc.

**SECTION 3:**

Members shall be eligible to hold office and to vote in person on all questions at all membership meetings. No employee or paid consultant of The Arc may serve as an Officer, Director, voting committee member or member of the Board of Directors.

**SECTION 4:**

Control of The Arc shall rest with the membership. Any action of the Board of Directors shall be subject to review by the membership on request of any member at a regular meeting or at a special meeting of the membership called according to the terms of Article VI hereof for that purpose. An action of the Board of Directors may be altered or rescinded with an affirmative vote of two-thirds (2/3) of the membership present or by written proxy.

**SECTION 5:**

Any member whose actions are prejudicial to the interests of The Arc, or of any person with developmental disabilities may be expelled as follows:

A member may bring written complaint against another member, and submit it to the President. The complaint shall present evidence to substantiate the accusation.

The President shall notify the affected member that such an action will come before The Arc's Board. A summary of the evidence shall be offered in support of the action, as well as the time, date, and place the Board will meet to consider the action.

Written notice will be provided to the member bringing the complaint and the member who the complaint is against at least thirty (30) days prior to the date action will be considered and an opportunity will be provided to show cause why the member should be suspended or expelled.

Upon an affirmative of three-fourths (3/4) vote of the Board of Directors at a Meeting with a Quorum, the affected member will be expelled.

The affected member shall have the right to appeal the decision to the general membership. On receipt of an appeal, the President shall call a special meeting within thirty (30) days at which the membership, having established a Quorum, may overrule the decision of the Board of Directors by an affirmative vote of three-fourths (3/4) of the membership present.

**SECTION 6:**

No member shall act or speak in the name of The Arc without the approval of the President.

**SECTION 7:**

Membership lists shall not be published or made available outside The Arc except where, in the opinion of the Board, the furnishing of such lists, in confidence to a public or private agency will be in the best interest of the members and will serve the purposes of The Arc.

**ARTICLE V**  
**DUES**

Members shall pay yearly dues as set by the Board of Directors. This amount shall include dues to the state and national components of The Arc.

**ARTICLE VI**  
**MEMBERSHIP MEETINGS**

**SECTION 1:**

A membership meeting will be held at least every thirteen (13) months and designated as the Annual Meeting for the election of Directors. The date of the Annual Meeting shall be set by the Board of Directors or the membership, and members shall be notified of the meeting date at least thirty (30) days in advance. The Annual Meeting may not be omitted.

SECTION 2:

Special Meetings may be called by the President or on written application of one-fifth (1/5) of the members made to the Secretary who shall mail notices to all members not less than thirty (30) days prior to the meeting stating the purpose of the meeting. Only business specified in the meeting notice may be transacted at a Special Meeting.

SECTION 3:

No action taken at an Annual or Special membership meeting shall have any effect unless a Quorum is present in person or by written proxy. A Quorum shall consist of ten percent (10%) of the membership or thirty (30) members in good standing, whichever is greater.

**ARTICLE VII**  
**FISCAL YEAR**

The Fiscal year shall begin July 1 of each year and end on June 30 of the following year.

**ARTICLE VIII**  
**BOARD OF DIRECTORS**

SECTION 1:

The Board of Directors shall consist of the elected Officers, the Immediate Past President (if available) and the Directors. There shall not be less six (6) Directors nor more than fifteen (15) Directors. The exact number of Directors within such maximum and minimum shall be fixed by resolution of the Board of Directors from time to time.

No compensation shall be paid to any Officer or Director for any services rendered to The Arc.

SECTION 2:

Directors of The Arc shall be elected by the membership for a term of three (3) years. No Director may serve more than three (3) full consecutive terms.

SECTION 3:

Meeting of the Board of Directors for the transaction of such business as may come before the meeting shall be held monthly or as frequently as determined by the Board of Directors on a date and hour fixed by the Board of Directors or by the President in the event of the failure of the Board of Directors to fix the date and time of each meeting. The Board of Directors, by majority vote, may dispense with the holding of any regular meeting of the Board of Directors.

SECTION 4:

Special meetings of the Board of Directors may be called with one (1) week's notice by the President or by Secretary upon the written request of three (3) Board members. Only that business stated in the call for the Special meeting may be discussed or acted upon.

SECTION 5:

If a vacancy in the position of Director occurs after the regular elections at the Annual Meeting, the Board of Directors may appoint an interim Director to perform the duties usually required by this position until the next Annual Meeting. At the next Annual Meeting, a successor to fill the unexpired term will be elected.

SECTION 6:

A Quorum shall consist of a majority of the number of Directors.

SECTION 7:

The Board of Directors shall be responsible for the conduct of the business of The Arc and shall be empowered to employ and prescribe the duties of the professional personnel as required to administer the affairs of The Arc. The Board of Directors shall exercise all powers inherent in The Arc except those expressly reserved to the membership. All actions taken by the Board of Directors must be passed by a majority of a Quorum present in person.

**ARTICLE IX**  
**OFFICERS**

SECTION 1:

The Officers of The Arc shall be a President, Vice President, a Secretary and a Treasurer, each of whom shall be elected by a majority of the Quorum of the Board of Directors. The Officers are elected for a term of one (1) year, but no Officer shall be eligible for the same office more than three (3) successive terms.

SECTION 2:

The President shall preside at all meetings of The Arc and of the Board of Directors and shall perform the duties usually associated with the office of President. With the advice of the Board, the President shall appoint the Chairperson and members of all standing and special committees, and supervise their work by being an ex-officio member of each committee. The President shall present a final annual report to the membership and be responsible for a copy being sent the state and national offices of The Arc along with the audited financial report.

SECTION 3:

The Vice President shall succeed to the Presidency in the case of a vacancy in that Office and shall perform the duties of the President in the President's absence or disability. The Vice President shall perform such other duties as from time to time may be assigned by the Board of Directors or by the President.

SECTION 4:

The Secretary shall ensure that records are accurate and maintain the proceedings of all meetings of the membership and of the Board of Directors. The Secretary shall be responsible for all correspondence of The Arc's Board of Directors and for notifying the members of all general membership meetings and the Directors of all Board meetings. The Secretary shall mail a copy of The Arc's revised Constitution and Bylaws to the state and national components of The Arc for approval.

SECTION 5:

The Treasurer shall be responsible for the oversight of the receipt, recording, deposit and disbursement of all The Arc's funds. The Treasurer shall present a written financial report at each regular meeting of the Board of Directors and the membership and submit all financial reports required for affiliation with The Arc. The Treasurer shall deliver to his or her successor all funds, records, paper and financial documents in his or her possession. Appropriate bonding coverage for Directors and employees of The Arc should be maintained.

**ARTICLE X**  
**NOMINATIONS AND ELECTIONS**

SECTION 1:

The Nominating Committee shall be composed of at least three (3) Members, at least two (2) of whom are Board Members, as appointed by the President of The Arc.

SECTION 2:

The Nominating Committee shall recommend a single slate of candidates for membership on the Board of Directors, to the Board of Directors at least one (1) month prior to the Annual meeting. The Board of Directors shall amend and or ratify such slate of candidates by majority of a Quorum of Directors at a Board of Directors meeting and recommend to the general membership a single slate of candidates for membership of the Board of Directors. The Board of Director's nominations for membership on the Board of Directors shall be mailed to general membership at least thirty (30) days prior to the Annual Meeting.



SECTION 3:

Nominations for the Board of Directors shall be permitted from members in good standing in attendance at the Annual Meeting. All nominees shall be members in good standing who have given their consent to the nomination.

SECTION 4:

Directors shall be elected at the Annual Meeting and shall take office on the first day of the month of the new fiscal year (July 1).

SECTION 5:

The newly elected Board of Directors shall select from their membership a President, Vice President, Secretary and Treasurer. Officers shall be elected at the July Board of Directors meeting after the Annual Meeting, and they shall take office immediately. Each officer serves for one (1) year and can serve up to three (3) consecutive one (1) year terms.

**ARTICLE XI**  
**STANDING COMMITTEES**

The President, with the advice of the Board of Directors, shall determine the standing committees of The Arc.

**ARTICLE XII**  
**EXECUTIVE DIRECTOR**

SECTION 1:

The Board of Directors may employ an Executive Director, establish the duties of the position and fix the salary. The Executive Director shall serve under the direction of the Board of Directors and shall function within the policies established by The Arc and the Board of Directors.

SECTION 2:

The Executive Director shall be the administrative head of The Arc, serving at all times under the direction and at the pleasure of the Board of Directors through the President. The Executive Director shall be responsible for implementing and executing policies, programs, and activities approved by the Board of Directors and the membership of The Arc. He or she shall also assist in developing goals and objectives and recommending policies, activities, and programs for the consideration of the Board of Directors and its membership, to make full use of the energies and proficiencies of the membership in strengthening The Arc and carrying out its objectives. The Executive Director shall have the authority to employ, terminate and fix the duties and salaries of the other employees of The Arc subject to policies adopted by the Board of Directors.

SECTION 3:

The Executive Director is authorized to speak for The Arc, but not beyond such limits as may be established by the Board of Directors.

SECTION 4:

The Executive Director shall not enter contractual agreements except under authority delegated by the Board of Directors.

**ARTICLE XIII**  
**RELATIONSHIP WITH STATE AND NATIONAL COMPONENTS**

The Arc agrees to remain in good standing with the state and national components of The Arc, to work constructively with these associations and to adhere to their policies.

The Arc further agrees to send to the state and national offices of The Arc such reports, financial information, membership transmittals, etc., that are reasonably requested, and to provide financial and other support as it may reasonably be requested from time to time.

**ARTICLE XIV**  
**PARLIAMENTARY AUTHORITY**

Robert's Rules of Order-Newly Revised shall govern the conduct of business in all meetings of The Arc as appropriate and to the extent that they are not in conflict with the Constitution and Bylaws of The Arc.

**ARTICLE XV**  
**AMENDMENTS**

These Bylaws may be amended with an affirmative vote of two thirds (2/3) of those members present at the Annual Meeting or at a Special Meeting called for the purpose of amending the Bylaws. Any proposed amendment shall have been presented in writing to each member at least three (3) weeks in advance of the meeting at which the vote is to be taken.
