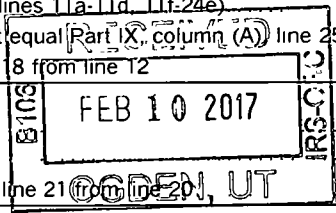

Residential Services for developmentally disabled adults. The Edwards Center has reduced occupancy of a 10 bed home to 5 bed and added a new 5 bed facility. The 15 homes continued upgrades and maintenance to homes that support individuals in a safe, pleasant home. 24 hour staff support is provided so that individuals can enjoy recreational and educational opportunities in the community. In addition, staff provides support to many individuals so they can live independently in their own apartments.

4b (Code) (Expenses \$ 3,198,933. including grants of \$) (Revenue \$)

Employment Services to developmentally disabled adults. The Edwards Center packaging and assembly business created jobs with paychecks for over 120 people with significant disabilities. The focus has shifted to job training, job coaching and pursuit for placing individuals in community jobs. In addition, retirements and therapeutic activities, and training are provided on a daily basis for those who are not working. this includes specialized programs for those are medically fragile and with significant needs.

Transportation Services for developmentally disabled adults. Edwards Center's fleet of vehicles transport our residential clients to work, to medical appointments, shopping, and recreational activities. Drivers are specially trained to provide transport.
