Clients may obtain food once every 4 weeks though some exceptions allow for more frequent service.

In 2016 Newberg FISH E.S. provided 4,697 food boxes of an average weight of 50 pounds.

FISH provided food to be distributed as part of a weekend "backpack" program for school-age children in low-income homes.

FISH provided food for police to carry in cars to feed homeless individuals they encounter on their routes.

Payment is in the form of a voucher to the participating business, FISH is billed by the pharmacy or dentist per the voucher.

Clients never receive cash.

In 2016 6 individuals received prescription aid. 9 individuals received dental aid
