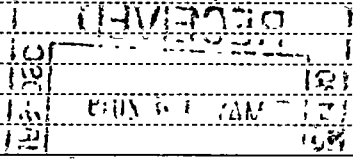

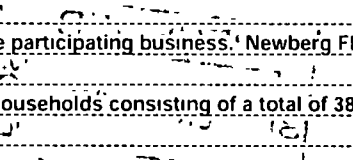

Clients may obtain food once very 4 weeks though some exceptions allow for more frequent service  
In 2017 Newberg FISH E.S. provided food to a household 4,745 times averaging approximately 50 pounds of food.  
FISH provided food to be distributed as part of a weekend "backpack" program for school-age children in low-income households  
FISH provided food and restaurant vouchers for police to carry in cars to feed homeless individuals they encounter on their routes.  
FISH provided food to a homeless shelter to be distributed for weekend meals
