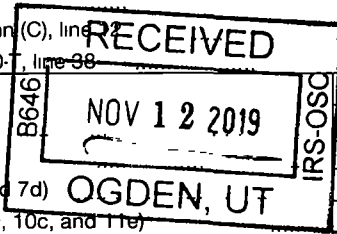

IN 2018-2019, 131 YOUNG PEOPLE PARTICIPATED IN SERENDIPITY'S THERAPEUTIC SCHOOL PROGRAM. IN EVERY SCHOOL DISTRICT IN THIS REGION, THERE ARE STUDENTS FACING CHALLENGES THAT MAKE SUCCESSFUL PARTICIPATION IN PUBLIC SCHOOL IMPOSSIBLE. WITHOUT EFFECTIVE HELP AND THE CHANCE TO START OVER, THESE CHILDREN CAN BECOME DISRUPTIVE, UNSAFE, AND HIGHLY DISCOURAGED ABOUT THEIR FUTURES.
