Ronald McDonald House Charities of Oregon and Southwest Washington (RMHC) provides a free "home away from home" for families of children facing serious illness, providing access to some of the most specialized medical treatment available. A child's medical treatment shouldn't be restricted based on proximity to home, and a family shouldn't worry about where they can afford to stay during treatment or where they will get their next meal. At RMHC, we believe that when a child is hospitalized, the love and support of a family close by is as powerful as the strongest medicine prescribed. RMHC provides 56 rooms a night across three houses: 25 room East House serving Randall Children's Hospital, 25 room East House serving Doernbecher Children's Hospital and a 6 room house in Bend serving St. Charles Medical Center. The Bend house is a new addition to RMHC after a successful merger with the Ronald McDonald House Charities of Central Oregon on October 1, 2016, allowing for cohesive services across the state. In 2016, we had 19,404 guest night stays, over 1800 family visits and hosted nearly 3000 children. Guest are very satisfied with service, indicated a 4.98 (out of 5) satisfaction rating. In addition to providing a homelike setting where families can connect through shared experience, RMHC also provides a number of support services to families including: meals prepared by volunteers nearly every day of the week, access to a fully stocked pantry for family meal preparation, a "grab and go" breakfast for families each day who are heading to the hospital, assisted animal therapy. On site babysitting. Full craft room for children's activities. Game room for teen activities. Transportation services, including scheduled visits to the grocery store. Clothing closet. Holiday events and support. Music therapy through MyMusicRx partnership. Volunteers providing services such as massage, hair cuts, etc.
