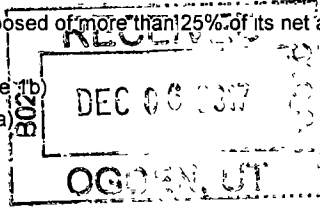

Children's Community Clinic (CCC) provided high quality and compassionate healthcare for children of underserved families regardless of ethnicity or ability to pay, focusing on wellness and prevention. In 2016, CCC provided 1,026 healthcare visits for 739 children. Of this number, 4% of them were uninsured; 94% were on the Oregon Health Plan, and less than 2% had private insurance. More than 80% of the children served were from families with incomes at or below 100% of the federal poverty level.
