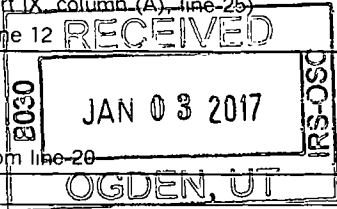

ARTICLES OF INCORPORATION
OF

A NON-PROFIT CORPORATION**

ARTICLE I

Name

The name of the Corporation shall be Cascade Capital Funding. An Oregon Non-Profit for public benefit without members.

ARTICLE II

Duration

The period of duration of this Corporation is perpetual.

ARTICLE III

Board of Directors

The affairs of this Corporation shall be conducted by a Board of Directors and Bylaws which shall govern the management and operation of the Corporation. The Board of Directors shall have a minimum of nine (9) and a maximum of fifteen (15) directors, with the number of directors to be fixed or changed periodically by the Board of Directors within this minimum and maximum range for the number of directors. Each director shall serve a term of three (3) years and until that director's successor is elected pursuant to the Bylaws of the Corporation. The terms of the directors will be staggered with one-third of the terms of directors expiring each year. At each annual meeting of the Board of Directors, the then existing directors will, by majority vote (with any deadlock to be broken by the vote of the Chair of the Board), elect directors for terms of three (3) years to succeed those directors whose terms expire.

ARTICLE IV

Distribution upon Dissolution

Upon the dissolution of this Corporation, after paying or adequately providing for the debts and obligations of the Corporation, all the remaining assets of the Corporation shall be disposed of and distributed exclusively for the purposes of the Corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code as amended from time to time. Any such assets not so disposed of shall be disposed of by the Circuit Court of the County in which the Registered Office of the Corporation is located, exclusively for such purposes or to

such organization or organizations as said Circuit Court shall determine are organized and operated exclusively for such purposes.

ARTICLE V

Purpose of Corporation

A. Non-Profit Corporation:

This is a Corporation organized as, and to be operated as, a non-profit corporation under Oregon and United States Internal Revenue law, and organized and operated exclusively for the promotion of social welfare, by helping communities and counties by stimulating the growth and expansion of businesses, including small businesses, within the State of Oregon. This Corporation will assist the growth and expansion of such businesses by providing financial assistance and services as allowed or required under Section 503 of the Small Business Investment Act (15 U.S.C. Section 687). In providing such financial assistance and services, this Corporation will assist new or expanding businesses that will create jobs and otherwise enhance the common good and welfare of the people of the State of Oregon. This Corporation is not organized for profit, and no part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(4) of the Internal Revenue Code as the same is amended from time to time.

B. Certified Development Company:

This Corporation may engage in any lawful activity in furtherance of its purposes. The primary purpose of this Corporation is to be a certified development company under Section 403 of the Small Business Investment Act (15 USC 687) and thereby promote and assist the growth and development of business concerns in the State of Oregon.

ARTICLE VI

Amendment to Articles

These Articles of Incorporation may be amended by the affirmative vote of at least two-thirds of the Board of Directors at a duly called meeting.

ARTICLE VII

Indemnification

The Corporation shall have the power to fully indemnify, protect, defend and hold harmless any director, officer, employee or agent of the Corporation for any action such director, officer, employee or agent takes or any liability to which such director, officer, employee or agent is exposed by reasons of the relationship or connection of such director, officer, employee or agent with this Corporation. This power shall be a full and complete as allowed by applicable Oregon and federal law.

These Restated Articles of Incorporation are executed this 14th day of June, 2016, in the name of the Corporation by David Green, its Board President, who declares under penalties of perjury that these Restated Articles of Incorporation constitute the act and deed of the Corporation and the facts stated herein are true.
