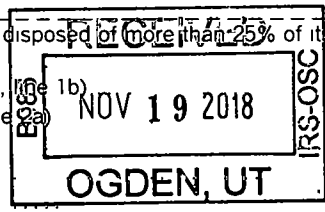

Most of the food is donated by individuals and is contributed at food drives, community events and dropped off at SACA's doorstep. In addition to community donations, SACA receives produce, bakery products and other goods from local grocery stores and other vendors.

SACA has been working on improving its accountability for food donations, but does not have detailed contribution records for all food donations.

For many years SACA has received \$80,000 to \$95,000 a year in food donations from local grocery stores. The amounts are disclosed on Schedule B of this return.
