Our programming works to prioritize students disproportionately underrepresented in careers and engages industry, school and other community partners to ensure student success.**

**BEC STEM Connect - This BEC program brings local businesses and neighborhood schools together to shift student attitude toward science, math and careers. Reaching more than 3,600 students in its third full program year with demonstrated student outcomes, STEM Connect is responsible for the reimagining of our vision and mission. 2017 promises to be an exciting year of piloting and deepening programming at the middle and high school levels to help us reach historically underserved students through our business and school partnerships.**
